#### **Executive Summary**

The One-day International Conference on Palestine: Exploring Asian Perspectives, held on 4 November 2024 at the University of Malaya, Kuala Lumpur, Malaysia, was a collaborative initiative organized by the Asia Middle East Center for Research and Dialogue (AMEC), University of Malaya, and the Hashim Sani Centre for Palestine Studies. The conference aimed to provide a platform for experts, academics, policymakers, and activists to engage in discussions on the humanitarian crisis in Gaza, with a specific focus on the role and responses of Malaysia and the broader Asian community.

#### **Key Themes and Objectives**

The conference addressed the ongoing challenges faced by the Palestinian people and explored strategies for a united Asian response. It had four primary objectives:

- 2. To explore Malaysia's and Asia's humanitarian and diplomatic responses to the conflict.

#### Introduction

The One-day International Conference on Palestine: Exploring Asian Perspectives brought together thought leaders, academics, policymakers, and activists to explore and discuss the Asian response to the ongoing situation in Gaza. With a strong focus on the humanitarian crisis and the role of Asian nations and organizations, the conference sought to foster dialogue, solidarity, and action for Palestine within the Asian context.

#### **Conference Highlights**



#### **Opening and Welcoming Remarks:**

The conference commenced with an inspiring Welcoming Speech by Dr. Nur Al Deen, Senior Research Fellow at AMEC and Conference Director. Dr. Nur Al Deen highlighted the importance of the event in creating a collective voice for Palestine across Asia and expressed gratitude to all attendees and partners.

Following the welcoming speech, Puan Sri Norma Hashim, Founder of the Hashim Sani Centre for Palestine Studies, delivered Opening Remarks that emphasized the importance of solidarity in times of crisis and the role of educational institutions and organizations in promoting the Palestinian cause.







#### **Keynote Addresses:**

**Keynote Speech 1:** YBhg Tan Sri Datuk Seri Syed Hamid bin Syed Jaafar Albar, Honorary Advisor of AMEC, spoke on Malaysia's long-standing support for Palestine and the need for diplomatic initiatives that address the root causes of the conflict.

**Keynote Speech 2:** YB Tuan Syed Ibrahim Syed Noh, Head of the Malaysian Parliament Caucus for Palestine, provided insights on policy developments within Malaysia aimed at supporting Palestine and urged greater involvement from Asian nations to bring about change.

#### **Panel Discussions:**











**Session 1** explored the Malaysian Response to the Gaza Genocide, moderated by Dr. Ferooze Ali, lecturer of UniSZA and Senior Research Fellow, AMEC. Panelists discussed Malaysia's active role in humanitarian aid, policy advocacy, and public mobilization.

Mr. Chua Tian Chang: Discussed the role of Malaysian civil society and NGOs in raising awareness and mobilizing aid.

Mrs. Nurul Izzah Anwar (video): Shared insights on Malaysia's humanitarian efforts and the need for legislative support.

Dr. Noraishah Hanifa: Presented research on Malaysian media portrayals of Palestine.

Mr. Jismi Johari: Spoke about the initiatives of Malaysian Humanitarian Aid Relief (MAHAR) in Gaza.











**Session 2** addressed Asian Responses to the Gaza Genocide, moderated by Mr. Khalid Jimat, with speakers from Japan, Thailand, Indonesia, and other Asian regions sharing perspectives on policy challenges, civil society involvement, and media narratives supporting Palestine.

Prof. Dr. Mohd Nazari Ismail: Analyzed the economic and political dynamics affecting Palestine.

Mr. Saul Takahashi (video): Provided a perspective on Japan's response and its foreign policy challenges.

Dr. Aina Thaipratan: Focused on Thailand's stance and public opinion on Palestine.

Ms. Nabila Osman: Discussed the Indonesian perspective and NGO collaboration.

Bapak Tengku Zulkifli Usman: Highlighted Indonesian political dynamics related to Palestine.





#### **Closing Remarks and Book Launch**

In his Closing Remarks, Dr. Muslim Imran,



Director AMEC, expressed of gratitude to all partners, speakers, participants, emphasizing and AMEC's commitment to advocacy and collaboration for Palestine. The event concluded with a book launch by Dr. Noraishah Hanifa Universiti Pertahanan Nasional Malaysia (UPNM), marking an academic contribution to the literature on Palestine.



#### **Media Coverage and Impact**

The conference received extensive media coverage from major outlets including NST, Bernama, Malaysiakini, and Harian Metro, amplifying the conference's message of solidarity and drawing attention to the humanitarian crisis in Gaza. This widespread coverage underscored the importance of a unified Asian narrative in advocating for Palestine.
